

PARENT NOTIFICATION & PERMISSION FORM

Dear Middle School Students & Parents,

This notification and permission form indicates, by initials and signatures, that both student and a parent or guardian have read, discussed, understand, and agree to abide by the policies, guidelines, expectations, and consequences outlined in the Middle School Handbook and Program of Studies, Technology Acceptable Use Agreement, and related school regulations and procedures of The Miami Valley School. All of these documents are available on the middle school section of the MVS website. As is often the case with delineating community expectations for appropriate conduct and behavior, accomplishing the intent of such policies requires members of the school community to abide by both the “written letter” and “implied spirit” of these policies, guidelines, and procedures.

Student:

As a student, I understand that using the network services within The Miami Valley School are privileges, intended for approved educational purposes. My access to these privileges may be suspended or revoked by MVS at any time if I do not follow the terms of the MVS Technology Acceptable Use Agreement. To that matter, I agree to keep my password confidential and to properly log off the computer before leaving my workstation. In short, I will not allow anyone to use or have access to my computer account.

As a condition of my use of the MVS network services, I have read and will comply with the terms and conditions stated in the Technology Acceptable Use Policy for The Miami Valley School. I understand disciplinary action will be taken if I violate the letter of or spirit implied in this agreement.

Parent or Guardian:

As the parent or guardian of this student, I have read the terms and conditions of the Technology Acceptable Use Agreement. I understand access to the network services is a privilege, not a right, and is provided for approved educational purposes. However, I also recognize it is impossible for The Miami Valley School to restrict access to all possible controversial materials. Therefore, I will not hold the school or any member of the school responsible for inappropriate communication on the network services or for any objectionable material viewed or used by my student.

I hereby give my permission for my student, whose name and signature appear below, to use the network services provided by The Miami Valley School and, where appropriate, to be issued a password and/or an account that will give them access to the network services.

In addition, we have read the policies, guidelines, and procedures detailed in the Student Handbook.
